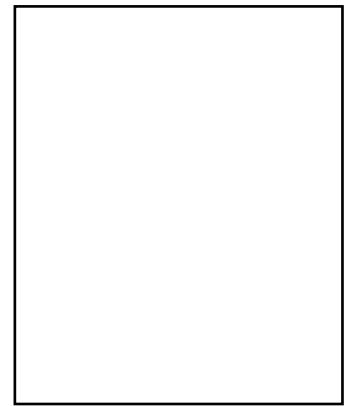

JOYKIDS SCHOOL RULES AND REGULATIONS

Welcome to Joykids. Our goal is to provide a safe, caring, and supportive learning environment for every child. Parents and guardians are kindly requested to read and follow the rules below.

1. School Fees

- 1.1 School fees are compulsory for all parents and guardians and are payable for 12 months of the year.
- 1.2 School fees must be paid on or before the 1st day of every month.
- 1.3 Parents and guardians must provide proof of payment with the child's name and surname clearly used as the payment reference.
- 1.4 School fees remain payable even if a child is absent due to illness, holidays, transfers, or any other reason.
- 1.5 One full calendar month's written notice must be given before withdrawing a child from the school.
- 1.6 If notice is not given, the parent or guardian will remain responsible for the outstanding fees.

2. School Hours

- 2.1 School operating hours are from 06:00 to 17:00.
- 2.2 Aftercare operates from 17:00 to 19:00.
- 2.3 Parents are requested to collect children on time.

3. Health and Safety

- 3.1 Children who are sick or have contagious illnesses such as flu, rashes, eye infections, or similar conditions must stay at home until they are fully recovered.
- 3.2 A medical note may be requested before the child returns to school.
- 3.3 Joykids will always take reasonable care to ensure the safety and well-being of every child.
- 3.4 In the event of an emergency, the school may seek medical assistance for a child if a parent or guardian cannot be reached.

4. Uniform and Personal Belongings

- 4.1 Children must attend school in the correct school uniform.
- 4.2 Teachers are not responsible for the loss of earrings during play.
- 4.3 Parents are kindly requested to clearly mark all clothing, bags, bottles, and personal belongings with the child's name and surname.
- 4.4 Beads in girls' hair are not allowed at school, as hair beads are considered a health and safety hazard.
- 4.5 Joykids will not be held responsible for lost clothing, jewellery, toys, or personal belongings.

5. Food and Daily Requirements

- 5.1 Children may not bring outside food to school unless permission has been granted.
- 5.2 Parents must provide all required stationery and documents at the beginning of the school year.

6. Attendance and Communication

- 6.1 Parents or guardians must inform the school if a child is absent.
- 6.2 Parents are encouraged to maintain respectful communication with staff at all times.

7. Educational Tours and Trips

- 7.1 Educational tours and trips are compulsory for all children attending Joykids Nursery School.
- 7.2 Tours and trips form part of school fundraising efforts to improve the school.
- 7.3 No refunds will be given if a child does not attend a trip or tour.

8. School Diaries

- 8.1 All children attending Joykids Nursery School must have a school diary.
- 8.2 School activities, yearly plans, and important information are communicated through the diary.
- 8.3 Parents are requested to ensure that the diary is covered with plastic and kept neat at all times.

9. Indemnity and Consent

- 9.1 Parents and guardians give permission for their child to participate in school activities conducted by Joykids.
- 9.2 The school will take all reasonable precautions to protect every child while under its care.
- 9.3 Parents or guardians remain responsible for medical or hospital costs that may arise in the event of injury or illness.
- 9.4 By enrolling a child at JoyKids, parents and guardians agree to support and comply with these rules and regulations.

PROTECTION OF PERSONAL INFORMATION

Your privacy is very important to us, and all Personal Information collected will be handled in a lawful, justifiable and reasonable manner. We will be as open and transparent as possible with you as to how your Personal Information is handled.

For the purposes of this enrolment form, Personal Information is any form of information that is identifiable with you or (Child's name and surname), may include but is not limited to name, mailing address, phone number, email address, nationality, and medical history.

We generally process your Personal Information for the following purposes
